1. PURPOSE

This Request for Proposal has been issued by the Sedibeng District Municipality (Sedibeng District Municipality) in order to procure a product and solution against theft and vandalism of sewer pump stations.

2. INTRODUCTION

After thieves/vandals had stripped the pump stations of its pumps, pipes, control panel and cables at Emfuleni, at a cost of a few thousand rand, Sedibeng District Municipality seeks to appointed a service provider to design and build a facility that is arguably one of the most secure in South Africa for 44 pump stations. The pump stations need to be properly secure since they are situated in a very remote area on the outskirts of Emfuleni.

Sedibeng DM requires the services of an experienced Contractor to manufacture, supply and install a product and solution against theft and vandalism of sewer pump stations in and around Emfuleni

3. PROJECT MANAGEMENT AND REPORTING

The Project Director will be the Manager Infrastructure: Transport, Infrastructure & Environment who will chair the Project Steering Committee (PSC) that will be set up to steer the project. The Service Provider will identify a member of their team as their Contract Manager. This person will be the municipality contact point during the project.

In terms of project management there will be regular PSC meetings. For each of these meetings a brief status report will be submitted (in advance) by the Contract Manager, detailing progress against the project implementation plan.

- The fence will be supplied and installed strictly according to details and specifications as indicated on Drawing which form part of this quotation. Castle type spikes will be included as a fence topping.(attach Drawings)
