The purpose of these terms of reference is to request suitably qualified service providers to submit a comprehensive proposal and quotations to Sedibeng District Municipality (SDM) for the installation of nonslip wood laminate flooring **OR** nonslip porcelain tiles on the stairs in the Mayor's Parlour at SDM on the corner Beaconsfield Avenue and Leslie Street, Vereeniging.


